



## New Year- New Plan-New Future

During the latter part of 2020, Worker Justice Wisconsin underwent a strategic planning process where the Board of Directors and staff together decided to shift our worker center from primarily service-leaning to a model focused on collective worker organizing. We believe this is the best way to stop workplace injustices before they start!

Central to building collective worker power is a strong membership program that fosters community bonds. To that end, WJW will initiate its worker membership program in May of this year, raising consciousness about class exploitation and oppression, demonstrating why building worker power in collective actions is necessary for systemic change, and training workers to be organizing leaders.

Our vital community partners in this program are religious congregations, labor unions and other individual and community members committed to economic and social justice in the workplace. For the last several months we have been meeting with faith and labor leaders in order to increase awareness about the problems that non-unionized and immigrant workers face (problems exacerbated during the pandemic) and to strengthen our connections to a community of support for WJW worker-led actions and campaigns. We invite these partners to become WJW members to show solidarity and increase the power of the coalition around workers as they stand up for their rights. In summary, the elements of this WJW strategic plan are:

- ✓ A worker membership and organizing program that includes regular trainings, strategy sessions and celebrations.
- ✓ Faith community, union, and individual supporter membership program to build the power of the coalition for economic, racial and immigrant justice in the workplace. (Suggested minimum donation of \$100/organization/year or \$60/individual/year)
- Education and engagement with faith communities and labor unions

### **Take Action**

#### Oakwood Village

Please support Oakwood Village employees as they face a significant understaffing crisis. Over 300 employees were either terminated or left last year, and there were recently as many as 150 unfilled positions. This has led to employee burnout, with turnover rates over 86% in some departments. Instead of listening to their concerns, Oakwood executives have changed benefits and working conditions are in violation of federal labor laws.

### **Faith Outreach Update:**

Worker Justice WI has been intentionally working to foster and strengthen new and old relationships with the many Dane County religious communities. Grace Shockman has stepped in as our new faith outreach coordinator and since coming on board has connected with 22 congregations of various faith traditions. Some of the communities include: religious leaders and congregation representatives from Glenwood Moravian and Lakeview Moravian Churches, St. Thomas Aquinas Catholic Parish, Lighthouse Church, Beth Israel Center, Messiah Lutheran, and Lake Edge UCC. IN conversation with faith communities we've been asking for their involvement in three primary ways:

- Joining our efforts in building collective worker power through participation in our membership program, contributing a minimum annual membership fee of \$100, and providing a reliable contact person.
- Hosting an annual Labor in the Pulpit/On the Bimah/In the Minbar service

3. Signing onto our Faith and Labor Statement when available.

Outreach to faith communities has been very rewarding, as opportunities for authentic and long-term relationships are being laid down. This process has opened our eyes to the importance of understanding the mission, priorities, and work of faith communities and has also allowed us to ask how we too can be a resource. We continue to consider creative ways for engaging our collective audiences around the intersections of labor issues, knowing that racial justice, housing and food insecurity, immigration, human trafficking, and the effects of COVID-19 are all related to the work we do at Worker Justice WI. It is just the beginning of many exciting partnerships with faith communities!

#### **The Work Continues:**

Worker Justice Wisconsin is always looking into the ways to educate and empower workers. One great way to ensure equitable pay and a safe working environment is for workers to come together to form a cooperative.

Have you ever thought about being your own boss? Did you know that Worker Justice Wisconsin offers resources and education on how to start your own worker cooperative? # Mary, can you tell us a little bit about yourself?

I am a retired educator and union activist, a firm believer in the positive impact unions have in creating not just fair wages and safe working conditions, but in lifting the conditions for all working families and the general welfare of the entire community.

# What is your involvement with WJW and its previous incarnations (ICWJ and the WRC)?

In 2008, I became a donor to the Interfaith Coalition (ICWJ, one of the two organizations that formed Worker Justice Wisconsin in 2017). As President of the Wisconsin Education Association Council in 2011, when the

Governor introduced Act 10, the Interfaith Coalition and the Workers' Rights Center were both visible and vocal in that fight for worker rights, including collective bargaining. Since my retirement, I have served as a board member and then board chair.

# What has motivated you to be on the board and stay involved throughout the years?

Beyond the crisis experience of 2011, I remain active with Worker Justice Wisconsin because of the unique and critical position it serves for workers who often serve in the most underpaid and unsafe workplaces, and are the most vulnerable to discrimination, harassment, and abuse on the job. In assisting workers not only to reclaim wages, the work of the organization is to build cohesive worker power through collective action so that employers who knowingly practice dangerous and abusive practices find it more difficult to do so, because instead of individual workers, they meet the force of a group who join their interests together.

# What is your vision and hope for the future of Worker Justice Wisconsin?

My hope is that Worker Justice Wisconsin can become even stronger in the fight for the rights of all workers. The merger between ICWJ and the WRC has given us the opportunity to build a broader community of support that can be enlisted not just when an employer acts badly, but in awareness and understanding of everyone's role in assuring workplace justice for all.
